# **Executive Summary**

The Office of the Conservation Regulator (OCR) was established by the Department of Environment, Land, Water and Planning (DELWP) early in 2019 following an Independent Review of Timber Harvesting Regulation in Victoria's public native forests (The Review).

The OCR Timber Harvesting Compliance Unit undertook a special audit to assess allegations made by the ABC on 20 November 2018 regarding VicForests' timber harvesting activities. The special audit provided an important opportunity to identify improvements to information and procedures to ensure compliance with the regulatory framework for timber allocation.

The special audit had the following objectives:

- 1. Analyse all coupes on the Approved Timber Release Plan 2017 (Victorian Government Gazette 2017) against the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014)
- 2. Identify any coupes (or portions of coupes) on the Approved Timber Release Plan 2017 (Victorian Government Gazette 2017) whose boundaries exist beyond the Allocation (Amendment) Order 2014
- 3. Determine the extent of timber harvesting which has occurred outside the area the subject of the Allocation (Amendment) Order 2014
- 4. Determine if timber harvesting activities are scheduled for any coupes (to 30 June 2019) which are identified to be outside the area the subject of the Allocation (Amendment) Order 2014 (wholly or partially)
- 5. Produce and make publicly available a report regarding the assessment of VicForests' timber harvesting activities against the Allocation (Amendment) Order 2014.

Timber resources are vested in VicForests for the purposes of timber harvesting and related activities by means of an Allocation Order. Relevant to the time period of the special audit was the Allocation Order of Government Gazette S343 (Victorian Government Gazette 2013), and the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014). The map associated with both Allocation Orders ('Allocation Order Map') was the legal mechanism for determining the extent and location of where harvesting could occur for the entirety of this period.

The Allocation Order Map was produced at a scale and level of detail that meant the special audit could not accurately determine whether VicForests had planned or harvested coupes on the Approved Timber Release Plan 2017 that were outside of the extent and location where timber harvesting could legally occur. This is consistent with previous legal advice that the Allocation Order Map was not suitable for criminal prosecution of any unauthorised timber harvesting operations. For this reason, a more detailed spatial dataset, known as the 'Working Forest Areas' dataset [WFA, (formally named wfa\_20131001)] was obtained from the Department of Jobs, Precincts and Regions (DJPR) as being the best spatial representation of the area of State Forest subject to the Allocation Order 2013 and the Allocation (Amendment) Order 2014. While not legally enforceable, the WFA was used by OCR in the special audit to support the assessment of VicForests' timber harvesting activities and alignment with the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014).

#### Amendments to the Allocation Order

It is noted that following the commencement of the special audit, amendments to the Allocation Order and the Timber Release Plan were released on 24 April 2019. The Allocation (Amendment) Order 2019 (Victorian Government Gazette 2019a) and the Approved Timber Release Plan 2019 (Victorian Government Gazette 2019a) are not within scope for the special audit.

The results indicate that:

- Of the 3,289 coupes and other features such as planned road and track works featured in the Approved Timber Release Plan 2017, 201 coupes were found to be wholly or partially outside the WFA.
- Nearly 90 per cent (175) of all coupes found to be wholly or partially outside the WFA were not identified to be harvested or scheduled for harvesting.

- Five coupes were found to be at least 25% outside the WFA as scheduled for harvesting before the end of the 2018/19 financial year.
- In total, 112.4 ha was identified to have been harvested outside of the WFA, with three coupes accounting for 59.1 ha of this figure.

While OCR found harvesting outside the WFA, previous legal advice is that the WFA cannot be relied on for criminal prosecution of unauthorised timber harvesting operations.

In April 2019, the Victorian Government Gazetted Allocation (Amendment) Order 2019 (Victorian Government Gazette 2019a). This Allocation Order area is now clearly defined by the spatial data layer known as 'VicForests\_Allocation\_Apr2019'. These April 2019 changes to the Allocation Order incorporated recommendations from OCR to improve enforceability through the referencing of the spatial data used to define the Allocated area. The incorporation of this spatial data layer provides the legal mechanism with the necessary spatial detail to be practically applied in the field and during coupe planning, as well as for the purposes of compliance and enforcement.

Recommendations arising from this audit focus on improving the robustness of processes and systems to complement the changes made to the 2019 Allocation Order and will maximise the potential for effective regulation. They include:

- Ensuring robustness of spatial data that represents the Allocation Order and Timber Release Plan.
- Timely biannual updates of timber harvesting spatial data.
- Annual amendment and reconciliation between Allocation Order and key data sets.

As a result of the special audit, the OCR will also undertake a biannual compliance audit of VicForests' Timber Release Plan and timber harvesting activities, with respect to the Allocation Order.

# Background

On Tuesday, 20 November 2018, ABC News published an online article '*Australia's endangered forests are being 'stolen' and sold in hardware and office supplies'*, regarding the alleged illegal logging or planned illegal logging of thousands of hectares of State Forest in Victoria (Slezak, 2018). The topic also featured on ABC's 7:30 Report the following night (Government-owned logging company accused of illegally logging State Forest 2018). Briefly, the allegations stated that VicForests, the Victorian State-owned business responsible for the harvest, sale and regeneration of Victoria's State Forests, was harvesting, or planning to harvest, timber resources outside the area it had been allocated (known as the Allocation area, defined in the Allocation Order (Amendment) 2014). The ABC report also stated that it had identified 17 coupes that had either been logged or were planned to be logged, which were completely outside the area subject to the Allocation Order. Another 25 coupes were alleged to be at least 90% outside the area subject to the Allocation Order.

The OCR's Timber Harvesting Compliance Unit undertook a special audit to investigate these allegations and assess VicForests' timber harvesting activities (both planned and harvested) against the Allocation (Amendment) Order 2014 area, the area allocated to VicForests for the purpose of timber harvesting.

The OCR has regulatory responsibility for protecting the natural and heritage values of Victoria's environment, including setting standards, monitoring compliance and enforcing the law. The OCR is the regulator of State Forests and its resources. It undertakes both regular activities to monitor compliance and specific activities to determine compliance with the regulations.

The DJPR is responsible for the development of forest industries policy, and the management of timber resources including the establishment of an audit against the Allocation Order.

VicForests is responsible for undertaking the sale and supply of timber resources in Victoria State Forests, and related management activities, as agreed by the Treasurer and the Minister for Agriculture, on a commercial basis. Furthermore, VicForests must operate in a framework consistent with Victoria Government policies and priorities and in compliance with the laws relating to timber harvesting.

The special audit had the following objectives:

- 1. Analyse all coupes on the Approved Timber Release Plan 2017 (Victorian Government Gazette 2017) against the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014)
- 2. Identify any coupes (or portions of coupes) on the Approved Timber Release Plan 2017 (Victorian Government Gazette 2017) whose boundaries exist beyond the Allocation (Amendment) Order 2014
- 3. Determine the extent of timber harvesting which has occurred outside the area the subject of the Allocation (Amendment) Order 2014
- 4. Determine if timber harvesting activities are scheduled for any coupes (to 30 June 2019) which are identified to be outside the area the subject of the Allocation (Amendment) Order 2014 (wholly or partially)
- 5. Produce and make publicly available a report regarding the special audit of assessment of VicForests' timber harvesting activities against the area the subject of the Allocation (Amendment) Order 2014.

# **Allocation of State Forest Timber Resources**

In Eastern Victoria, VicForests is granted access to certain timber resources by means of an Allocation Order. Under Part 3 (section 13) of the *Sustainable Forests (Timber) Act 2004,* the Minister for Agriculture has authority to make an Allocation Order to VicForests, thereby allocating the timber resource in specified areas of State Forest to VicForests for purposes of harvesting and selling, or harvesting or selling timber resources (Victorian Government Gazette 2013).

Upon publication of an Allocation Order in the Victorian Government Gazette, the allocated timber resource is vested to VicForests for the above-mentioned purposes. The Allocation Order relevant to this special audit was published in the Victorian Government Gazette on Tuesday 1 October 2013 (Victorian Government




Figure 1. The Allocation Order Map, as per Government Gazette S343 (Victorian Government Gazette 2013)

Gazette 2013), with amendments made on 30 October 2014 (Victorian Government Gazette 2014). The extent and location of allocated forests are depicted in Figure 1, the map featured in Gazette S343 (Victorian Government Gazette 2013) and referred to as the Allocation Order Map.

Under Part 5 (section 37) of the *Sustainable Forests (Timber) Act 2004*, VicForests must prepare a plan, known as the Timber Release Plan (TRP), to make public the schedule and relevant details of State Forest timber resources that have been allocated for the purposes of harvesting and selling timber (as well as associated management activities such as silvicultural regime, roading and coupe access works and reforestation). The plan must be consistent with the Allocation Order to which the plan relates. The TRP is developed by VicForests and subject to consultation with stakeholders, including the public. Following this consultation, the TRP progresses to the VicForests' Board for approval. Notice of this approval is made in the Victorian Government Gazette. Where areas fall outside of an Allocation Order, alternative authorisations may be sought to legally harvest areas of State Forest. This is primarily achieved through a Forest Produce License issued under section 52 of the *Forests Act 1958*.

# **Data Analysis and Methodology**

#### Scope

This audit analysed only those VicForests coupes which are within the area of the Allocation Order and TRP, therefore excluded any VicForests coupes in Western Victoria (as per Figure 1). The Allocation Order relevant to this special audit was published in the Victorian Government Gazette on Tuesday 1 October 2013 (Victorian Government Gazette 2013) with amendments made on 30 October 2014 (Victorian Government Gazette 2014). The Approved Timber Release Plan 2017 (TRP 2017) which is relevant to this special audit was gazetted on 5 January 2017 (Victorian Government Gazette 2017).

The analysis of planned timber harvesting with the Allocation Order is limited to the Approved TRP 2017 up until 30 June 2018. The analysis of timber harvesting with the Allocation Order (and therefore the veracity of claims made by the ABC on 20 November 2018) is limited to the Approved TRP 2017 up until 31 October 2018.

Following the commencement of the special audit, amendments to the Allocation Order and the TRP were released on 24 April 2019. The Allocation (Amendment) Order 2019 (Victorian Government Gazette 2019a) and the Approved Timber Release Plan 2019 (Victorian Government Gazette 2019a) are out of scope for the special audit.

#### Sources of Data

A range of spatial and aspatial data sources were used to determine the extent of any planned or actual timber harvesting activities outside the area subject to the Allocation Order area (Table 1). Given the scale and extent of the mapped Allocation Order, as depicted in Appendix 1 of Government Gazette S343 (Figure 1), insufficient detail was available to allow for the necessary analysis required for the special audit to accurately determine whether VicForests had planned or harvested coupes on the Approved Timber Release Plan 2017 that were outside of the extent and location where timber harvesting could occur. For this reason, a detailed spatial dataset, known as the 'Working Forest Areas' dataset [WFA, (formally named wfa\_20131001)] was obtained from DJPR as being the best spatial representation of the area of State Forest subject to the Allocation Order 2013 and the Allocation (Amendment) Order 2014.

The Allocation Order Map and the WFA were established and maintained by the DJPR (and before it the Department of Economic Development, Jobs, Transport and Resources, DEDJTR) on behalf of the Minister for Agriculture. The former Department of Environment and Primary Industries (DEPI) developed the WFA dataset to represent the spatial extent and location of timber resources vested in VicForests under section 13 of the *Sustainable Forests (Timber) Act 2004*. This function now sits with the DPJR which maintains the WFA dataset. The WFA is recognised by the OCR and DJPR as the best representation of the area of State Forest subject to the Allocation Order 2013 and the Allocation (Amendment) Order 2014, noting that the map featured in Gazette S343 (Victorian Government Gazette 2013) was unchanged in the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014). The OCR considers that for auditing purposes, the WFA was the most reliable record of spatial data for assessing VicForests' timber harvesting activities with the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014).

While the WFA was the practical mechanism that OCR has used for the special audit, OCR note that the WFA was only a representation of the Allocated area and is not legally enforceable. The Allocation Order Map (referenced above) was the only legal mechanism for determining the extent and location of where harvesting could occur for the entirety of this period, and previous legal advice is that it is not suitable for criminal prosecution of any allegedly unauthorised timber harvesting operations.

It is also noted that VicForests raised issues of errors and inaccuracies in the WFA with the former DEPI, DEDJTR and DJPR since 2013, and sought to clarify the spatial extent of resources with DEDJTR in 2016.

Logging history spatial data was used to analyse harvesting activities relevant to the Approved TRP 2017. This spatial data is neither a contemporaneous source of harvest activities, nor a scheduling tool. Given this limitation, a list of coupes harvested in the 2018/19 season (up until 31 October 2018), and all those scheduled for the 2018/19 financial year, were requested from VicForests to complement the analysis.

#### Methodology


The TRP spatial data formed the basis for the final output, where additional attributes were added to indicate the proportion of the planned coupe area which was outside the WFA, whether it was harvested or planned to be harvested, as well as the hectare area harvested outside of the WFA. The process undertaken is described in Figure 2 and detailed in Appendix 1.


Two discreet pieces of analysis were undertaken to:

- 1. Determine coupes and coupe areas on the TRP that were outside the WFA
- 2. Determine the harvest area outside the WFA.

Analysis also flagged coupes that were scheduled for harvest in 2018/19, and those with harvesting history from 1 July 2018 - 31 October 2018.

All analysis was undertaken using ESRI ArcGIS software made available to DELWP via an Enterprise Agreement. Data analysis was completed on 1 March 2019.





#### **Key Considerations and Assumptions**

As the TRP map and data is not generated from the underlying WFA data, but rather is drawn and intended to be used at a landscape-scale; a degree of geometric variability between the two datasets exists and must be considered during analysis. To account for this variation, it was determined that coupes on the TRP which were found to be outside the WFA by less than 25% were excluded from further analysis regarding TRP non-conformance, as well as harvest scheduling or planning. This step accounted for the spatial variability between datasets, as well as any typical inaccuracies in source data (i.e. mapped vs true, in-field location of variables). If all TRP areas outside the WFA were subjected to the entirely 'literal' overlay analysis of comparing one data layer to another, false results that overstate the accuracy of the underpinning data layers would be unavoidable. TRP coupes less than 1 ha in size were also excluded from analysis to minimise these impacts.

These considerations and assumptions applied to the analysis for objectives, one, two and four of the special audit:

- 1. Analyse all coupes on the Approved Timber Release Plan 2017 (Victorian Government Gazette 2017) against the WFA
- 2. Identify and map any coupes (or portions of coupes) on the Approved Timber Release Plan 2017 whose boundaries exist beyond the WFA
- 4. Determine if timber harvesting activities are scheduled for any coupes on the Approved Timber Release Plan 2017 (to 30 June 2019) which are identified to be outside the WFA (wholly or partially)

When analysing harvesting history against the area defined by the WFA, non-conformance of less than 0.1 hectare (slivers) were excluded from further analysis. Harvest areas covered by alternate authorisation via a Wood Utilisation Plan or Timber Utilisation Plan were also excluded. These measures applied to the third objective of the special audit:

3. Determine the extent of timber harvesting which has occurred outside the area the subject of the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014)

Given the purpose of analysis, DELWP spatial data analysts were tasked with analysing the best available data in the state upon which it was published. As part of the initial analysis, it was identified that several coupe addresses in harvesting history datasets were incorrect. Steps were taken to ensure that these coupes were interrogated during analysis, however there were no changes made to the geometry of any spatial data sources used during the special audit.

# Results

#### Summary

The Approved TRP 2017 (Victorian Government Gazette 2017) featured 3,289 coupes representing activities including silvicultural regime, roading and coupe access works and reforestation. Using the WFA as the best spatial representation of the area of State forest subject to the Allocation Order 2013 and the Allocation (Amendment) Order 2014, 201 TRP coupes were identified to be outside the WFA (Table 2), including 51 coupes found to be wholly outside the WFA and the remainder outside the WFA to a lesser degree (Table 2). Of the 201 identified as outside the WFA, wholly or partially, five were scheduled for harvesting before the end of the 2018/19 financial year (Table 3). Nearly 90 per cent (175) of all coupes found to be outside the WFA, wholly or partially, were not identified to be harvested or scheduled for harvesting up until 30 June 2019. A full list of the 201 coupes is listed in Appendix 2.

#### **Planned Timber Harvesting**

As per data provided to DELWP by VicForests relating to VicForests' Harvesting Schedule from 1 July 2018 to 30 June 2019, five TRP coupes with portions existing outside the WFA were proposed for harvesting by the end of the 2018/19 financial year (Table 3).

#### **Completed Timber Harvesting**

Two separate analyses were performed to assess timber harvesting activities against the WFA, up until 31 October 2018.

The first analysis used the list of coupes for which a volume of timber was recorded as harvested from 1 July 2018 to 31 October 2018. Results showed that for coupes in which a volume was produced during this period, none were outside the WFA.

The second analysis used the available timber harvesting spatial datasets (LASTLOG25 & LOG\_SEASON) which included activities from 1 October 2013 to 30 June 2017. When independently analysing this harvesting history with respect to the WFA spatial data layer, 50 instances of timber harvesting across 48 different coupes were identified to have occurred outside the WFA, totalling 112.4 ha (Table 4 and Appendix 3). The degree of non-conformance ranged from 0.1 - 30.3 hectares, with just over half (59.1 ha) of the total amount harvested occurring across three coupes: 'Squirrels Paw', 'Little Jacqui' and 'Coyotes Paw' coupes. 30 instances of timber harvesting identified to have occurred outside the WFA were less than 1 ha in size.

# **Data Management Considerations**

During analysis, it was found that in seven instances, coupe addresses assigned to timber harvesting activities did not match that of the coupe address where the activity occurred. This was apparent for Squirrels Paw, Upper Billow, Roadhouse, Alstergrens Rd, Extra Well Done, Trevor, and Phillip Island. It is important that both VicForests and DJPR subject all timber harvesting data to relevant quality and validation processes to ensure that it accurately reflects the nature of any activities.

# Limitations

The Allocation Order Map was at a scale and level of detail that meant the special audit could not accurately determine whether VicForests had planned or harvested coupes on the Approved Timber Release Plan 2017 that were outside of the extent and location where timber harvesting could legally occur. This is consistent with previous legal advice that the Allocation Order Map was not suitable for criminal prosecution of any alleged unauthorised timber harvesting operations.

While OCR found harvesting outside the WFA, we note that the WFA was only a representation of the legally Allocated area, and previous legal advice is that it cannot be relied upon for criminal prosecution of any alleged unauthorised timber harvesting operations.

Any analysis completed as part of this special audit is dependent on the integrity of data sources which were analysed. The results of this analysis are also dependent on the sources of data used, the currency of these sources and the timeframe for which they represent any activity. Discussions of these results, broader interpretation and any extrapolation must be cognisant of such limitations.

# **Recommendations**

In April 2019, the Victorian Government Gazetted Allocation (Amendment) Order 2019 (Victorian Government Gazette 2019a). This Allocation Order area is now clearly defined by the spatial data layer known as 'VicForests\_Allocation\_Apr2019'. These April 2019 changes to the Allocation Order incorporate recommendations from OCR to improve enforceability through the referencing of the spatial data source used to define the Allocated area. The incorporation of this spatial data layer provides the legal mechanism with the necessary spatial detail to be practically applied in the field and during coupe planning, as well as for the purposes of compliance and enforcement.

Recommendations arising from this audit focus on improving the robustness of processes and systems to complement the changes made to the 2019 Allocation Order and will maximise the potential for effective regulation. They include:

- 1. VicForests ensures that it has the appropriate approvals for harvesting timber in or adjacent to the currently gazetted Allocation Order. This includes:
  - a) Through the direct mechanism of any gazetted Allocation Order; or
  - b) Through a Forest Produce Licence where required
- 2. VicForests provides biannual updates of timber harvesting spatial data to both DJPR and DELWP.
- 3. DJPR considers the appropriate timescale for the update of relevant, centrally-held spatial data library within a reasonable time of receipt.
- 4. DJPR and VicForests work with DELWP to develop and improve procedures to ensure robust end -toend data curation and governance practices including data validation, version control and registration.
- 5. DJPR consider an annual reconciliation between the Allocation Order and key datasets (i.e. the FMZ schema) and a subsequent gazettal, so as the Allocation Order accurately reflects timber resources available to VicForests via the Allocation Order.
- 6. DELWP and DJPR continue to improve spatial data relating to the zoning of forests and the allocation and use of timbers.

Furthermore, as a response to this review, the OCR will undertake a biannual assessment of VicForests' Timber Release Plan and timber harvesting activities, with respect to the Allocation Order. The OCR will also establish clear procedures for the licencing of VicForests' operations that fall outside any Allocation Order, and means of systematically recording these so that they are readily accessible.

# Appendix 1 – Process of Spatial Analysis

- 1. Add fields to the source Approved Timber Release Plan 2017 data to record harvesting history details, Forest Management Zone (FMZ), gross coupe area (in hectares), percentage outside the WFA, and comments field to allow description of results of the overlay process
- 2. Populate the coupes which were harvested or planned for harvest by linking the supplied tables ('VicForests' Harvesting Schedule' and 'Coupes with timber volume produced') on coupe address, and the attributes of LASTLOG25/Logging History data (using a 'Spatial Join'). This recorded the actual harvest area rather than an intersected area, since there were some differences in the coupe footprint between planned and actual harvesting
- 3. Simplify the WFA data layer (using the 'Dissolve' function), based upon FMZ value this was to remove the unnecessary detailed breakdown by forest type and therefore simplify for the final overlay analysis
- 4. Overlay the TRP with the simplified WFA (using the 'Identity' feature), retaining full TRP shapes
- Identify areas of TRP coupes that were outside WFA by selecting records that had a 'blank' FMZ value. A 'blank' FMZ value (derived from within the WFA data) indicated areas outside the area the subject of the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014).
- 6. Compute the percentage of the area in hectares
- Calculate the area (in hectares) of each coupe identified to be outside of the WFA and categorise the actual percentage of gross coupe area outside the WFA into the following groups: i) Wholly within WFA, ii) 1-25% outside, iii) 25-50% outside, iv) 50-75% outside, v) 75-99% outside and vi) Totally outside WFA
- For all coupes on the TRP, identify those which had harvesting occur outside the area the subject of the Allocation (Amendment) Order 2014 (Victorian Government Gazette, 2014) and calculate the area (in hectares) of any logging history (relevant to the scope of analysis) outside the WFA, through 'Overlay' analysis
